ALASKA FAMILY EDUCATION LOAN (FEL)



- **5.75%-6.00% APR** (5.75%-6.00% fixed rate)
- **\$24,000 annual loan limit** (undergraduate, graduate, & career training programs)

ALASKA EDUCATION LOAN REFINANCE (REFI)



- **4.60%-7.25% APR** (4.60%-7.25% fixed rate)
- **No fees & fixed APR never increases**
- **Consolidate private, state, & federal education loans**
- **Choose 5, 10, or 15 year repayment term**
- **Degree completion not required**
