




## **Survey Respondent Demographics**

Over 90% of respondents are Alaska high school seniors or recent high school graduates.


### Self-Identified Respondent Population

- Do you have a plan to pay for your postsecondary plans?
- Has the COVID-19 pandemic changed your interest in pursuing a career field deemed essential/critical? (i.e. healthcare, education, transportation)
- What are new factors that have influenced your decision to pursue PSE?







# Postsecondary Planning – Changes due to COVID-19

Of the survey respondents, 33% report that their PSE plans changed in some way due to the COVID-19 pandemic.

■ Pursue PSE in Alaska ■ Pursue PSE out-of-state ■ Not pursue PSE ■ Other/Don't Know







## Postsecondary Planning – Alaska PSE

Due to COVID-19, there is 2.75% decrease in Alaskans planning to pursue a AA/BA, but a 2.9% increase in those planning to pursue apprenticeship or certificate programs.

#### Current Alaska PSE Plans







## Postsecondary Planning – Out-of-State PSE



## **Impacts on PSE and Admissions Process**

Of the 16.25% of respondents who do not plan to pursue PSE immediately due to COVID-19, financial concerns and uncertainty are top factors.

### Factors in not pursuing PSE








## Impacts on PSE and Admissions Process

### Top Impacts on Admissions Process (check all that apply)








### Impacts on Distance-Delivered **Education**

27.89% of respondents stated that COVID-19 changed their interest in pursuing distancedelivered PSF

Of the 21.37% who answered "Other" in distance-delivered PSE plans, nearly all state that they are less inclined to pursue distance courses as a result of COVID-19.

■ Move out of Alaska and enroll in out-of-state distance-delivered program









### **Financial Aid Awareness**
