



## **FACTS** WHAT DOES The Alaska Commission on Postsecondary Education (ACPE) and Alaska Student Loan Corporation (ASLC) DO WITH YOUR PERSONAL INFORMATION?

**WHY?** Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

**WHAT?** The types of personal information we collect and share depend on the product or service you have with us. This information can include:

- Social Security Number and Account Transactions
- Account Balances and Payment History
- Transaction History and Credit History

When you are *no longer* our customer, we continue to share your information as described in this notice.

**HOW?** All financial companies need to share nonpublic personal information to run their everyday business. In the section below, we list the reasons financial companies can share their nonpublic personal information; the reasons ACPE & ASLC chooses to share; and whether you can limit this sharing.

**WHO WE ARE:****Who is providing this notice?**

**WHAT WE DO:****How does ACPE/ASLC protect my personal information?**

To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.

ACPE may record telephone calls made to or from customers as part of our quality control, staff training, and compliance programs.

**How does ACPE/ASLC collect my personal information?**

We collect your personal information, for example, when you

- Apply for loans or cosign for a loan
- Make a payment or apply for loan servicing options
- We also collect your personal information from others such as government agencies, credit bureaus and higher education institutions.

**Why can't I limit all sharing?**

Federal law gives you the right to limit only

- Sharing for affiliates' everyday business purposes – information about your creditworthiness
- Affiliates from using your information to market to you
- Sharing for nonaffiliates to market to you

State laws and individual companies may give you additional rights to limit sharing.

**DEFINITIONS:*****Affiliates***

Companies related by common ownership or control. They can be financial and nonfinancial companies.

- ACPE/ASLC has no affiliates

***Nonaffiliates***

Companies not related by common ownership or control. They can be financial and nonfinancial companies.

- Organizations providing ACPE with services related to your account, such as schools; credit bureaus; guaranty, collection, and government agencies; and contracted service providers.

***Joint Marketing***

A formal agreement between nonaffiliated financial companies that together market financial products or services to you.

- ACPE does not jointly market

**OTHER IMPORTANT INFORMATION:**

ACPE shares information about you as allowed by law, to perform business functions and provide you with appropriate levels of service. We disclose your nonpublic personal information only for legitimate business purposes and in compliance with applicable laws and regulations.
